

ORDINANCE 22-2020

AN ORDINANCE PROVIDING FOR ADDITIONAL PERMANENT APPROPRIATIONS AND ADJUSTMENTS TO VARIOUS LINE ITEMS FOR THE CURRENT EXPENSES AND FOR OTHER EXPENDITURES OF THE VILLAGE OF MADISON, OHIO, FOR THE PERIOD BEGINNING JANUARY 1, 2020 TO AND INCLUDING DECEMBER 31, 2020, AND DECLARING AN EMERGENCY.

WHEREAS, the Fiscal Officer requests this Council to authorize additional permanent appropriations and adjustments to various line items for current expenses and for other expenditures of the Village during the year 2020.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF MADISON, COUNTY OF LAKE AND STATE OF OHIO, THAT:

SECTION 1. To provide for current expenses and other expenditures of the Village of Madison, Ohio, for the period beginning January 1, 2020, to and including December 31, 2020 there be and hereby is appropriated the following amounts:


\$25,000.00	From: Unappropriated Coronavirus Relief Fund (2151)
\$10,000.00	To: Supplies & Materials- Covid-19 Items Admin (2151-790-400-0119)
\$ 6,000.00	To: Supplies & Materials – Covid-19 Items Police (2151-110-400-0119)
\$ 6,000.00	To: Supplies & Materials – Covid-19 Items M&R (2151-620-400-0119)
\$ 1,000.00	To: Supplies & Materials – Covid-19 Items Senior Center (2151-390-400-0119)
\$ 1,000.00	To: Supplies & Materials – Covid-19 Items Water (2151-533-400-0119)
\$ 1,000.00	To: Supplies & Materials – Covid-19 Items Sewer (2151-549-400-0119)

SECTION 2. It is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of the Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the residents of the Village of Madison, and further necessary to provide the Village of Madison the necessary funds for the operation of the Village during the period aforesaid; wherefore, this Ordinance shall take effect and be in force immediately upon its passage.


